### Advocacy for CEDAW implementation in Poland 2010-2012

KARAT has a pleasure to announce its new Project within its Women's Human Rights Program. The Project is related to the CEDAW reporting process in Poland where the Polish government is due to be reviewed in 2012. The Project includes production of the Shadow Report in coalition with national women's rights organizations and advocacy for the priority critical women's rights issues in Poland (e.g. adoption of parity and anti-discrimination act, reproductive rights). The Project also aims to assess women's access to justice and eliminate barriers that hamper litigation of their rights.

### Regional Consultation on the implementation of CEDAW Concluding Observations in Europe and Central Asia



On 1-3 July, European Consultation on the implementation of CEDAW Concluding Observations (COs) organized by IWRAW Asia Pacific in cooperation with KARAT and WIDE took place in Warsaw, Poland. During this 3-day meeting women's rights advocates from EU member states, CEE countries and Central Asia shared their strategies on using Concluding Observations (issued by the CEDAW Committee after the reviewing session of the given state), to keep the governments accountable for complying with the obligation to fully implement CEDAW Convention at the national level. The meeting was attended by 32 women from 17 countries, including KARAT's members.

Previous member of the CEDAW Committee – Shanthi Dairiam from Malaysia – was also present at the Regional Consultation, sharing her expertise and experience. Participants will carry out follow up activities for the implementation of CEDAW COs on national level. We will keep you updated on further developments via KARAT News.

### Through Their Eyes Through Ours: Notes from Georgia



Mila O'Sullivan who was one of the participants of data gathering tours to Caucasia that took place as part of "Through Their Eyes, Through Ours" project has produced a report from her tour titled "Notes from Georgia: Respecting Women as Equal – a Way Forward". In this interesting piece of writing Mila states that "When it comes to social transformation and particularly gender equality as a prerequisite to development, Georgia can be portrayed as a traditional society with some deeply embedded patriarchal values. Yet, traditions are not static and one can notice Georgia is undergoing a social change. While *de jure* gender equality framework is being strengthened, progress towards *de facto* gender equality situation remains a great challenge especially in the rural areas."

KARAT Coalition is taking part in the work of the Coalition for Equal Chances in Poland - an unofficial platform of a number of Polish well-known NGOs promoting human rights and equality. It has been created in response to the fact Polish government's work on the project of equality law is of substandard quality, disappointing and not always transparent.

The Coalition is coordinated by Polish Society of Anti-Discrimination Law and monitors the preparation of the project of equality law. It also tries to initiate a substantial dialogue with the government. Unfortunately, by now its voice has been ignored.

Poland still does not have any equality law. There is only a very general statement in the Constitution referring to equality.

### **Gender Alliance for Development Centre (Albania): Shadow report submitted to CEDAW Committee**

A group of representatives from the Albanian women's rights NGOs has participated in the 46<sup>th</sup> Session of the Committee of CEDAW. The delegation presented the recommendations based on the shadow reports on the periodical report of the Albanian government. One of the shadow reports has been initiated by the Gender Alliance for Development Centre (member of KARAT Coalition).

The authors of the Shadow Report listed a number of problems faced by Albanian women. The question of unemployment and informal work was among them. The Albanian NGOs delegation has underlined that economic empowerment of women is a very important step towards the elimination of gender discrimination and gender based violence.

### **Women Support Centre (Kyrgyzstan): A new project in response to the political upheaval**

Women Support Center (WSC) and Women-Entrepreneurs Support Association (WESA) are launching a new large project, titled "Accountability of Government and Involvement of the Women's Movement for Women's Political and Economic Empowerment".

In Kyrgyzstan, with the women's right movement facing major hurdles caused by the political upheaval and ethnic conflict, this project will address the need for strengthening the participation of civil society organizations in monitoring the fulfillment of gender equality commitments in the country. The project, which will directly impact more than 40,000 internally displaced women, community leaders, local government representatives, civil society activists and community members, will also advocate for gender-sensitive legislation to promote women's political participation and sustainable livelihoods, particularly in response to increased violence against women in the midst of conflict. The project aims to increase women's access to political and economic rights guaranteed by national and international legal documents.

The project is funded by the UNIFEM.

### **EU: European Institute for Gender Equality officially opened**

On 20 June, the European Institute for Gender Equality (EIGE) in Vilnius (Lithuania) was officially opened. The EIGE is a new EU Agency which supports the EU Institutions and Member States in promoting gender equality and fighting discrimination based on sex. It collects data and statistics on gender-equality issues and help the European Commission make evidence-based policy decisions. The EIGE is the first EU agency based in one of the Baltic States.

### **UN Women Born**

On 2 July 2010 the United Nations General Assembly voted unanimously to create a new entity to accelerate progress in meeting the needs of women and girls worldwide. The establishment of the UN Entity for Gender Equality and the Empowerment of Women — to be known as UN Women — is a result of years of advocacy by the global women's movement and negotiations between UN Member States. It is part of the UN reform agenda.

The new Gender Equality Entity to be headed by an Under-Secretary General, will consolidate the four existing UN bodies on women and increase operational capacity at the country level. It has gained increased funding for work on women's empowerment and advancement. The UN currently has four separate entities dedicated to women's issues which will be combined in the new entity: the UN Development Fund for Women (UNIFEM), the Division for the Advancement of Women (DAW), the International Research and Training Institute for the Advancement of Women (INSTRAW), and the Office of the Special Adviser to the UN Secretary-General on Gender Issues and Advancement of Women (OSAGI).

UN Women will, among other issues, work for the elimination of discrimination against women and girls, empowerment of women, achievement of equality between women and men as partners and beneficiaries of development, human rights, humanitarian action and peace and security.

UN Women will be operational by January 2011.

### **CONCORD: "Penalty Against Poverty..."**

CONCORD's AidWatch Report 2010 titled "Penalty Against Poverty. More and better EU aid can score Millennium Development Goals" states that gender equality is a key factor in fostering sustainable development. It has been proved that poverty can only be eradicated through gender-sensitive development policies. Despite this fact, CONCORD points out that gender remains a marginal issue in official aid effectiveness processes and that gender equality is still perceived as a by-product of development processes, rather than as an instrument to improve people's lives.

CONCORD is pushing the EU to maximize its contribution to the MDGs, reminding it that there is still time left to shape up before the UN MDG Review Summit in September. CONCORD has also prepared concrete guidelines that the EU needs to follow to achieve better aid effectiveness.
